### 1. Approval of February 21, 2023 Minutes

The proposal for ECO 101 was submitted by Dr. Aslihan Spaulding, interim chair, Department of Economics. The proposal for ECO 102 was submitted by Dr. Susan Chen, Professor, Department of Economics. The Council decided to review the proposals together.

Council members felt both courses were a good fit for the SS designation. Ferrence noted that both courses are considered General Education courses at other institutions. Aitken added both courses currently count for IAI requirements but do not fulfill General Education requirements at Illinois State.

A motion was made by Aitken to approve both courses for the SS designation. Rivadeneyra seconded.

A vote was taken. All in favor, none opposed, none abstained.

## 5. MQM 120 Equity, Diversity, and Inclusion in the Workplace (revision to existing SS course)

The course was proposed by Dr. Tina Williams, chair, Department of Management and Quantitative Methods. The Council previously reviewed and tabled the proposal at a previous meeting.

Ferrence reminded Council members the proposal had been sent back to the department at a previous meeting. During that meeting, it was noted the course description was well over the 41-word limit. The proposer was asked to condense the description to comply with the limit. The department re-submitted the proposal with the edited course description.

Ferrence and Nance noted the revised course description was well within the specified word limit and members did not have any concerns regarding the proposed course revisions.

A motion was made by Califf to approve MQM 120 for the SS designation. Clemmons seconded.

A vote was taken. All in favor, none opposed, none abstained.

The motion passed.
