Council on General Education Minutes September 19, 2023 10-11:00 a.m., STV 140

Ferrence called the meeting to order at 10:01 a.m.

Action Items:

1. Introductions

Introductions were made. The Council welcomed new member, Joshua Newport as the Undergraduate Curriculum Committee representative.

2. Approval of September 5, 2023 Minutes

Ferrence asked if there were any corrections to the minutes as submitted. There were no corrections. The minutes were accepted as submitted.

3. IDS 310 Innovation Consulting Community (new IDS course)

The course was proposed by Dr. Peter Kaufman, Professor, Department of Marketing.

Ferrence reminded Council members of the previous meeting's discussion regarding the course. During the previous meeting, Council members noted a syllabus had not been submitted as part of the proposal. Kaufman revised the proposal to include the syllabus. Hurd added that the course was not repeatable for credit and would not count in the Entrepreneurship minor which were two questions the Council raised in its previous discussion and Kaufman provided answers to.

After reviewing the syllabus, Worland raised the question regarding students having to complete prep modules the semester prior to taking the course. He noted the modules counted toward 20% of the final grade per the syllabus and wondered if there was already a precedent in place for such a requirement. Clemmons noted her City as Text courses require students to complete prep work. Newport noted it wasn't unusual for capstone courses within the majors to require students to complete prep work prior to the course. Aitken asked if students registered for two classes in this instance. Newport verified that was the case. Council members could not determine if students could wait to complete the modules once the course began or if they had to be completed prior to the start of the course. Council members also wanted to ensure the course was following Registrar procedures and wondered if the modules could be taken on a pass/fail basis. Ferrence suggested the Council invite Kaufman to attend a future meeting to discuss the Council's concerns.

Worland made a motion to table the course and invite Kaufman to attend a Council meeting to discuss the Council's questions. Aitken seconded.

All in favor, none opposed, none abstained.

The motion passed.

Simmons will contact Kaufman to invite him to attend a future meeting.

Information Items:

4. General Education Assessment Update - Ryan Smith

Smith distributed handouts to Council members to give them an overview of the proposed General Education assessment plan and an overall update. See Appendix A.

Smith explained how the proposed plan would utilize Canvas to pull course information for assessment. Council members discussed the benefits and potential issues with using Canvas in this way depending upon the diverse types/nature of assignments collected across General Education courses. Following discussion, Ferrence asked Smith what his expectation was from the Council. Smith responded he would like to have an endorsement from the Council to move forward with the proposed plan. Ferrence asked Council members to review the plan and it would be added as an action item for the next meeting.

5. Council Member Vacancy Update

Newport mentioned he had received an internal departmental update that announced the new representatives to fill the Council's vacancies. Ferrence asked if the individuals had been contacted by the Council. Simmons noted the Council had not received official notice of the appointments from the Academic Senate. She will follow-up with Academic Senate Chair Horst.

Ferrence made a motion to adjourn. Clemmons seconded.

- An evaluation process will capture student, faculty and staff perspectives on general education.


A gen ed assessment plan does not:

What's working?

- Faculty discipline, content, teaching and curriculum design expertise.
- A governance entity devoted to general education (CGE).
- Instructional design professionals in the Center for Integrated Professional Development (CIPD).
- · Assessment and evaluation capacity in academic and student affairs.
- Learning theory experts in a variety of disciplines (psychology, communications, human development, etc.).
- An LMS (Canvas) to organize and collect assessment results.
- Quantitative and qualitative data analysis infrastructure in UAS, EDA and the CGE.
